Tina:

Hello! I left a phone message for you but I thought I would e-mail you as well. I have an urgent drafting request for you regarding AB 360. I'll assume with the changes that I'm requesting it may have to be in the form of a sub. If not, a simple amendment is fine.

The Committee on Public Health is meeting next Tuesday to exec on AB 360. They won't and can't exec if I don't get the changes to them by 8:30 on Monday. I'm sorry the request is so late but a compromise on the changes was just agreed upon. Rep. Freese has requested and appreciates your expedience with regards to this issue.

Essentially what we want to do is create a section of statute similar to section 2 on page 2 of the bill. It could read something like this:

"No permit may be issued under this section for a public swimming pool, whirlpool or spa that is *under* 1000 square feet unless the public swimming pool, *whirlpool or spa* employs or contracts with a person who holds a valid certificate granted by the department under s. 254.475 or *passes an approved course as determined by the department by rule.*"

I've italicized the major changes. The effective date of this would coincide with section 2 on page 2 (36 months). With this change I'm assuming we could then delete section 3 on page 2 and delete section 5 (3) on page 4.

Please call me 6-7502 or Tom Jackson in Sen. Schultz's office 6-0703 with any questions. Again, please make this a priority. I really appreciate it!


