

**ASSEMBLY AMENDMENT 1,  
TO ASSEMBLY AMENDMENT 1,  
TO 1999 ASSEMBLY BILL 389**

June 23, 1999 – Offered by Representative HOVEN.

1 At the locations indicated, amend the amendment as follows:

2 **1.** Page 1, line 2: after that line insert:

3 “1m. Page 8, line 14: after that line insert:

4 “(he) “Federal base amount” means all moneys received from the federal  
5 government under 42 USC 8621 to 8629 in federal fiscal year 1999–2000 and under  
6 42 USC 6861 to 6873 in federal program year 1999–2000.

7 (hm) “Federal fiscal year” means the period beginning on October 1 and ending  
8 on the following September 30.

9 (hp) “Federal funding amount” means all moneys received from the federal  
10 government under 42 USC 8621 to 8629 in a federal fiscal year after federal fiscal  
11 year 1999–2000 and under 42 USC 6861 to 6873 in the federal program year

1 beginning in the same calendar year as the calendar year in which the federal fiscal  
2 year begins.

3 (hs) “Federal program year” means the period beginning on April 1 and ending  
4 on the following March 31.”.

5 **2.** Page 1, line 3: delete lines 3 to 5 and substitute:

6 “2m. Page 9, line 3: delete lines 3 to 19.”.

7 **3.** Page 1, line 8: before that line insert:

8 “5m. Page 10, line 7: delete lines 7 to 9.”.

9 **4.** Page 1, line 9: delete lines 9 to 12 and substitute:

10 “6m. Page 10, line 24: delete the material beginning with “In each” and ending  
11 with “(5).” on page 11, line 9.”.

12 **5.** Page 2, line 1: delete lines 1 to 3 and substitute:

13 “9g. Page 12, line 8: delete the material beginning with “who receives” and  
14 ending with “3. a.” on line 10.

15 9r. Page 12, line 11: after “(a)” insert “unless the person is a customer of a utility,  
16 as defined in s. 196.374 (1) (c), that makes a contribution to the commission under  
17 s. 196.374 (3) for deposit in the utility public benefits fund”.

18 **6.** Page 2, line 7: delete lines 7 and 8 and substitute:

19 “13g. Page 13, line 7: delete lines 7 to 10.

20 13r. Page 13, line 11: delete the material beginning with “1.” and ending with  
21 “year.” on line 12.”.

22 **7.** Page 2, line 9: after that line insert:

23 “14t. Page 14, line 5: after that line insert:

1           “5. Submit to the joint committee on finance a plan for adjusting the amount  
2           that utilities are required to contribute to the commission under s. 196.374 (3) based  
3           on the amount of moneys received from the federal government under 42 USC 6881  
4           to 6873 and 42 USC 8621 to 8629. A plan under this subdivision shall require the  
5           department to determine the difference between the federal base amount and the  
6           federal funding amount for each federal fiscal year after federal fiscal year  
7           1999–2000 and require the commission to do one of the following:

8           a. If the federal base amount is greater than the federal funding amount,  
9           increase the contributions that utilities are required to make to the commission for  
10          low–income assistance under s. 196.374 (3) in the calendar year following the start  
11          of the federal fiscal year by an amount equal to the difference between the federal  
12          base amount and the federal funding amount.

13          b. If the federal funding amount is greater than the federal base amount,  
14          decrease the contributions that utilities are required to make to the commission for  
15          low–income assistance under s. 196.374 (3) in the calendar year following the start  
16          of the federal fiscal year by an amount equal to the difference between the federal  
17          funding amount and the federal base amount, except that if the difference is equal  
18          to or greater than the contributions that are otherwise required for low–income  
19          assistance under s. 196.374 (3) no contributions shall be required for low–income  
20          assistance.

21          6. Implement a plan specified in subd. 5. that is approved or modified by the  
22          joint committee on finance.”.”.

23          **8.** Page 2, line 13: after that line insert:
