- 1 At the locations indicated, amend the substitute amendment<sup>✓</sup> as follows:
- 2 1. Page 1, line 4: delete "construct,"<sup>✓</sup>
- 3 2. Page 2, line 8: delete that line and substitute "taxable year to purchase  
4 equipment for use at a licensed day care"<sup>✓</sup>.
- 5 3. Page 3, line 6: after "s. 48.65"<sup>✓</sup> insert "and that verifies that the claimant's  
6 employes are offered access to the day care center on an equal basis".
- 7 4. Page 3, line 11: after the period insert "No credit may be allowed under this  
8 subsection for any expenses that the department of revenue determines are  
9 unreasonable."<sup>✓</sup>
- 10 5. Page 3, line 19: delete "construct,"<sup>✓</sup>
