1 *in senate*  
AN ACT ...; relating to: leaving or storing a loaded firearm within the reach or  
2 easy access of a child.

---

### *Analysis by the Legislative Reference Bureau*

Current law provides various penalties for recklessly storing or leaving a loaded firearm within the reach or easy access of a child who is younger than 14 years old. This bill broadens the coverage of that law so that it applies to leaving a loaded firearm within the reach or easy access of a child who is younger than 18 years old.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

3 SECTION 1. 948.55 <sup>x</sup>(1) of the statutes is repealed.

4 SECTION 2. Initial applicability.

5 (1) This act first applies to offenses occurring on the effective date of this  
6 subsection.<sup>✓</sup>

If the analysis indicates that a fiscal estimate is required because the proposal makes an appropriation or increases or decreases existing appropriations or state or general local government fiscal liability or revenues, you have the option to request the fiscal estimate prior to introduction. If you choose to introduce the proposal without the fiscal estimate, the fiscal estimate will be requested automatically upon introduction. It takes about 10 days to obtain a fiscal estimate. Requesting the fiscal estimate prior to introduction retains your flexibility for possible redrafting of the proposal.
