Assumptions Used in Arriving at Fiscal Estimate

The existing Public Accommodations Law covers golf facilities and complaints against golf facilities are already accepted by the Department. This bill specifically adds golf facilities to the list of covered establishments. In addition it provides additional enforcement mechanisms and exceptions, and specifies acts that are prohibited.

In state fiscal year 1999, 94 complaints of discrimination in public accommodations were filed. It is not anticipated that passage of this legislation will result in any additional workload or costs to the department, other than a \$1,000.00 cost to reprint copies of the law.

If golf facilities are complying with the existing public accommodations law, it is anticipated that there will be no additional costs to local government. If complaints are filed there may be some minimal costs to municipalities that process complaints and revoke licenses. Since only 94 complaints of discrimination in public accommodations were filed throughout the state during fiscal year 1999, a significant number of complaints filed with municipalities is not anticipated.


