1997 ASSEMBLY BILL 937

March 19, 1998 - Introduced by Representatives SERATTI, SPILNER, GOETSCH, GREEN, OWENS, KREIBICH, LADWIG, KELSO, SPRINGER, OTT, AINSWORTH and GROTHMAN, cosponsored by Senator FARROW. Referred to Committee on Campaign Finance Reform.

1 AN ACT to repeal 11.06 (3) (b); and to amend 11.06 (1) (intro.) and 11.12 (4) of  
2 the statutes; relating to: reporting of information by nonresident registrants  
3 under the campaign finance law.

**Analysis by the Legislative Reference Bureau**

Currently, with certain exceptions, registrants under the campaign finance law are required to file regular reports with the appropriate filing officer or agency. The reports must identify contributors of more than \$20<sup>v</sup> cumulatively within a calendar year, the occupation and principal place of employment, if any, of each contributor whose cumulative contributions within a calendar year exceed \$100; the registrants from whom or to whom funds are transferred; other income exceeding \$20; contributions donated to a charitable organization or the common school fund; loans exceeding \$20 together with the identity of the lenders and guarantors, if any; disbursements (expenditures) and obligations exceeding \$20; and certain information from registrants making disbursements independently of candidates. However, if a registrant does not maintain an office or street address within this state, the registrant need only identify contributions, transfers, loans and other income received from sources in this state and disbursements and obligations incurred with respect to elections for state or local office in this state.



If you choose to introduce the proposal without the fiscal estimate, the fiscal estimate will be requested automatically upon introduction. It takes about 10 days to obtain a fiscal estimate. Requesting the fiscal estimate prior to introduction retains your flexibility for possible redrafting of the proposal.
