AN ACT to create 77.54 (44) of the statutes; relating to: exempting sales of

United States flags and state flags from the sales tax and the use tax.

Analysis by the Legislative Reference Bureau

This bill creates a sales and use tax exemption for the United States flag and the state flag.

This bill will be referred to the joint survey committee on tax exemptions for a detailed analysis, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- **SECTION 1.** 77.54 (44) of the statutes is created to read:
- 77.54 (44) The gross receipts from the sale of and the storage, use or other consumption of the United States flag or the state flag. This subsection does not apply to a representation of the United States flag or the state flag.
