5 40.73 (1) (am) Upon the death of a participating employe who has not attained 6 age 55, and any protective occupation participant who has not attained age 50, the 7 sum of the additional contribution and twice the employe required contribution 8 accumulations credited, including any interest credited to the accumulations, to the 9 participant's account on the beneficiary annuity effective date or, in the case of a 10 lump sum payment, the first day of the month in which the death benefit is approved.

12 40.73 (1) (c) In lieu of the benefit payable under par. (a) or (b), upon Upon the 13 death of a participating employe who, prior to death, met all of the requirements 14 under s. 40.23 (1) except termination of employment and the filing of an application, 15 if the beneficiary to whom a death benefit is payable is a dependent of the 16 participating employe natural person, or a trust in which such a beneficiary the 17 <u>natural person</u> has a beneficial interest, the present value on the day following the 18 date of death of the life annuity to the beneficiary which would have been payable 19 if the participating employe had been eligible to receive a retirement annuity, 20 computed under s. 40.23 or 40.26, beginning on the date of death and had elected to 21 receive the annuity in the form of a joint and survivor annuity providing the same 22 amount of annuity to the surviving beneficiary as the reduced amount payable 23 during the participant's lifetime. If there is more than one beneficiary the amount 24 of the annuity and its present value will be determined as if the oldest of the 25 beneficiaries were the sole beneficiary. If the death benefit payable to the beneficiary
