1 AN ACT...; relating to: the amount of the exemption from income tax withholding  
2 requirements for employes of a county fair association. ✓

*Analysis by the Legislative Reference Bureau*

Under current law, in general, every employer must withhold from an employe's wages an amount that is determined by the department of revenue according to withholding tables that are prepared by the department. Current law exempts from this withholding requirement any county fair association, with regard to an employe who receives less than \$100 annually in wages <sup>or</sup> salary from the association.

This bill increases the exemption amount to \$300. ✓

This bill will be referred to the joint survey committee on tax exemptions for a detailed analysis, which will be printed as an appendix to this bill.

For further information see the *state* fiscal estimate, which will be printed as an appendix to this bill.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

If the analysis indicates that a fiscal estimate is required because the proposal makes an appropriation or increases or decreases existing appropriations or state or general local government fiscal liability or revenues, you have the option to request the fiscal estimate prior to introduction. If you choose to introduce the proposal without the fiscal estimate, the fiscal estimate will be requested automatically upon introduction. It takes about 10 days to obtain a fiscal estimate. Requesting the fiscal estimate prior to introduction retains your flexibility for possible redrafting of the proposal.
