2 1. Page 1, line 8: after "purposes" insert ", a sales tax and use tax exemption
3 for nonprescription drugs". 22

4 2. Page 12, line 25: after that line insert:

5 "SECTION 28m. 77.54 (14v) of the statutes is created to read:

6 77.54 (14v) The gross receipts from the sale of and the storage, use or other
7 consumption of nonnarcotic drugs which may be sold without a prescription and
8 which are prepackaged for use by consumers and labeled in accordance with the
9 requirements of state and federal law."

10 3. Page 13, line 9: delete "This act first applies" and substitute "The treatment
11 of sections 71.04 (5) (intro.), (6) (intro.), (7) (d), (8) (b) and (c) and (10), 71.25 (7)
12 (intro.), (8) (intro.), (9) (d), (10) (b) and (c) and (11) and 71.45 (3) (intro.), (a) and (b),
13 (3d) and (3m) of the statutes, the renumbering and amendment of sections 71.04 (4)

71.05(6)(b) 20. (intro.) and 29.

8 takes effect on the first day of the 2nd month beginning after publication."
