5 The joint legislative council is requested to study why there is a disparity in the  
6 proportion of prison inmates who are members of racial minorities compared to the  
7 proportion of racial minorities in the state's population as a whole and what can be  
8 done to ameliorate or eliminate the causes of the disparity. If the council undertakes  
9 such a study, it shall report its findings, conclusions and recommendations, together  
10 with any proposed legislation, to the legislature in the manner provided under  
11 section 13.172 (2) of the statutes by May 1, 2001."
