TO 1999 ASSEMBLY BILL 465

1 At the locations indicated, amend the bill as follows:

2 1. Page 190, line 22: delete lines 22 to 24 and substitute:

3 *text:* "(g) Study why there is a disparity in the proportion of prison inmates who are
treat
4 members of racial minorities compared to the proportion of racial minorities in the
5 state's population as a whole and submit annual reports discussing its findings and
6 making recommendations concerning how to ameliorate the disparity. No later than
7 January 1, 2001, the commission shall submit an initial report under this paragraph
8 to the governor, to each house of the legislature under s. 13.172 (2) and to the supreme
9 court. The commission shall submit additional reports on January 1 of each year
10 thereafter that discuss any additional findings and recommendations of the
11 commission and that discuss the impact, if any, of recommendations made by the
12 commission under this paragraph that have been implemented."
