ASSEMBLY AMENDMENT,  
TO 1999 ASSEMBLY BILL 469

1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 16: after "pardoned" insert "except that it is employment  
3 discrimination because of conviction record to refuse to employ or to terminate from  
4 employment a person who has been convicted of a felony under s. 943.61<sup>✓</sup> more than  
5 5 years prior to the refusal to employ or termination of employment and who has not  
6 been pardoned, unless par. (cp) 1m.<sup>✓</sup> applies".

7 2. Page 3, line 3: after that line insert:

8 "1m. Has been convicted of a felony under s. 943.61<sup>✓</sup>, the circumstances of which  
9 substantially relate to the circumstances of the particular job, and has not been  
10 pardoned for that felony;"
