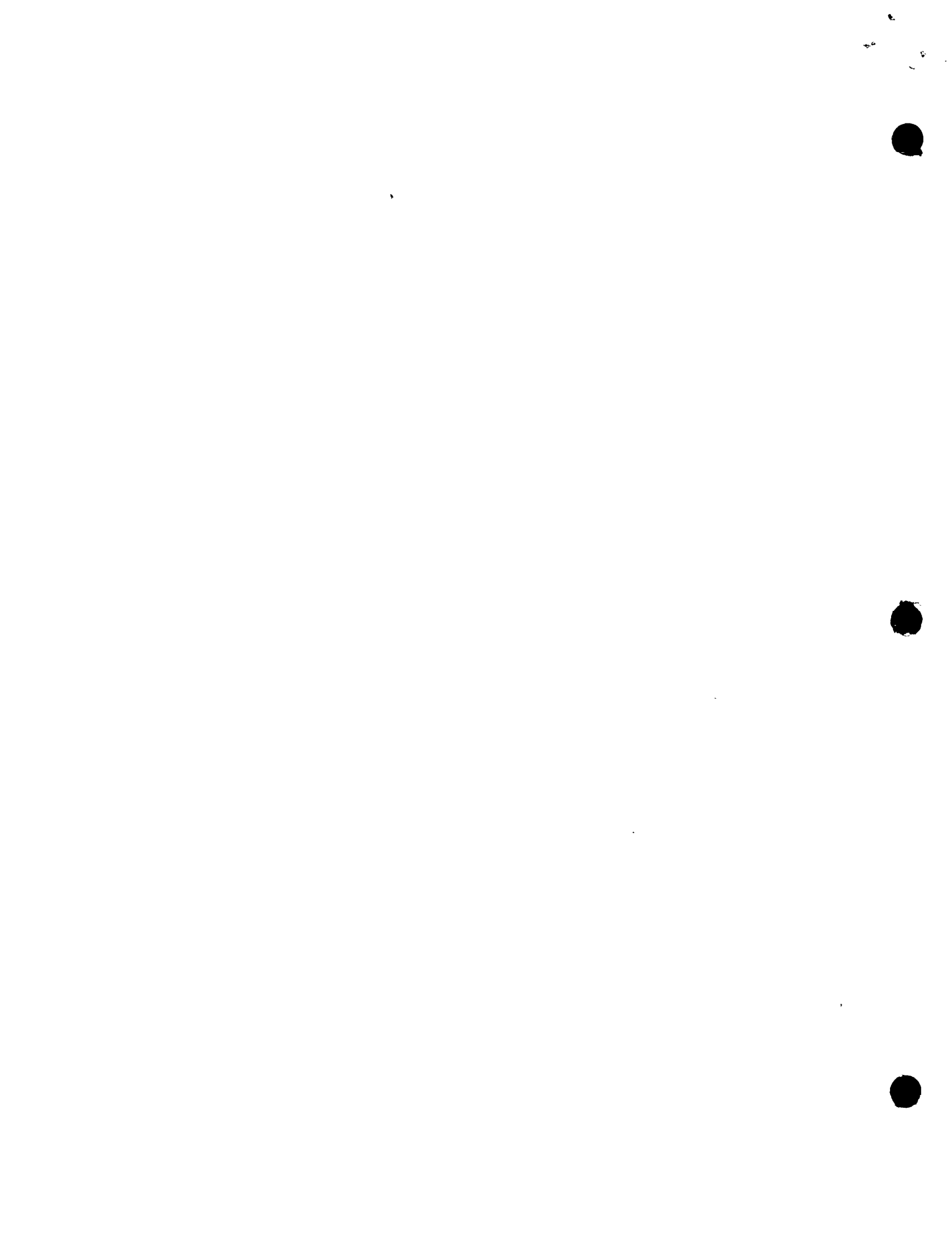

Section #. 346.945 (2) and (3) (a) of the statutes are amended to read:

~~346.945(2)~~ Any ~~member of the public~~ ^{person} who observes a violation of ~~346.945(1)~~ ^{ss. 346.67 to 346.69} may prepare a written report indicating that a violation has occurred. If possible, the report shall contain the following information:

- (a) The time and the approximate location at which the violation occurred.
- (b) The license number and color of the motor vehicle involved in the violation.
- (c) Identification of the motor vehicle as an automobile, station wagon, motor truck, motor bus, motorcycle or other type of vehicle.

~~346.945(2)~~ Within 24 hours after observing the violation, a ~~member of the public~~ ^{person} may deliver a report ^{prepared under} ~~containing all of the information in sub. (1)~~ ⁽³⁾ to a traffic officer of the county or municipality in which the violation occurred. A report ^{that} ~~which~~ does not contain all of the information in sub. ⁽³⁾ ~~which~~ nevertheless ^{nevertheless} be delivered and shall be maintained by the county or municipality for statistical purposes.

~~346.945(2)~~ Within 48 hours after receiving a report containing all of the information in sub. ⁽³⁾ ~~which~~, the traffic officer shall investigate the violation and may prepare a uniform traffic citation under s. 345.11 and, within 72 hours after receiving such report, any traffic officer employed by the authority issuing the citation may personally serve it upon the owner of the vehicle.
