Please draft five amendments to LRBa0144/2, the substitute to AB474 as follows:

1. page 1, line 12, insert, after "without": "...first notifying the parent or guardian in writing of the nature of the survey or questionnaire and the right of the student or parent to refuse participation under (d) [becomes (c).], page 1, line 12, delete, beginning with: "...the written consent of the..." thru page 2 line 3. page 2, delete line 16 thru 21 [the intent is to require notification, but not require written parental permission]
- ✓ 2. Specify that written permission is not required for anonymous surveys or questionnaires. (It may be necessary to identify the characteristics of an anonymous survey.) Page 2, line 16 thru 21, clarify that mailing a request for consent is required only for those surveys that require written parental consent.
- ~~3. Page 3, specify that forfeiture applies only to violations of the requirement to obtain written permission. *if not, then why*~~
- ✓ 4. Page 3, delete line 5 to end. *Keep sunset*
- ✓ 5. Page 3, line 6, delete last sentence. *if #2 passes, period only if written*
