The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 ~~SECTION 1.~~ 118.25 (3) of the statutes is renumbered 118.25 (3) (a) and amended
4 to read:

5 118.25 (3) (a) ~~In Subject to par. (b), in~~ counties having a population of less than
6 500,000, the school board may require ~~periodic health examinations of pupils by~~
7 physicians a pupil to be periodically examined by a physician, under the supervision
8 of a local health departments department and the department of health and family
9 services, ~~and.~~ The school board may pay the cost of the examinations out of school
10 district funds.
