**ASSEMBLY AMENDMENT ,
TO 1999 ASSEMBLY BILL 479**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 6: delete "section." and substitute "section, but if the minor
3 indicates that he or she does not agree to being tested for the presence of alcohol or
4 drugs in the minor's body, the person authorized by the parent or guardian to
5 administer the test may not administer the test until after the parent or guardian
6 and minor have participated in at least one counseling session for the purpose of
7 mediating that disagreement."
