1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 8: delete that line and substitute ~~“with a surety to be approved~~

4 2. Page 2, line 9: after “state.” insert “If the person is a Wisconsin resident, he
5 or she may use a surety that is approved by the clerk of the circuit court in the county
