~~September 28, 1999 - Offered by Representative HUEBSCH~~

1 At the locations indicated, amend the bill as follows:

2 1. Page 2, line 8: delete that line and substitute "with a surety to be approved  
3 by the clerk of the circuit court for his or her county, or,".

4 2. Page 2, line 9: after "state." insert "If the person is a Wisconsin resident, he  
5 or she may use a surety that is approved by the clerk of the circuit court in the county  
6 of the applicant's residence."
