3 <sup>Except as provided in subd. 2, if</sup>

5 promotes or informs the department that the organization intends to promote  
6 sectarian worship, instruction or proselytization in connection with the  
7 rehabilitation program, the department shall permit ~~all~~ <sup>cert (stat)</sup> other religious  
8 organizations <sup>(stat)</sup> meeting the requirements of this section to operate an inmate  
9 rehabilitation program under sub. (1). <sup>(END)</sup>
