3 “(3) This section does not provide immunity to a person who provides obstetric ✓  
4 and gynecological services to a woman if the person does not do all of the following:

5 (a) Provide all of the tests and procedures that the standard of care required  
6 of a reasonable practitioner of obstetric and gynecological services to women would  
7 require.

8 (b) Provide the woman with the results of all of the tests and procedures  
9 required under par. (a) in a manner that allows the woman to make an informed  
10 decision regarding future health care procedures.” ✓
