# 1999 BILL

AN ACT :; relating to: increasing the number of circuit court branches.

## Analysis by the Legislative Reference Bureau

This bill adds one circuit court branch in each of the following counties:

Chippewa

Juneau 🗸

Winnebago <sup>J</sup>

Green

Kenosha

Rock/

The circuit court judges for those branches are elected for year terms. The terms of the new branches for the circuit courts commence on **Aug**ust **1**, **2001**.

The bill also provides a court reporter for each judge.
