Re: Establish a Standing Date to be Proclaimed "Benefit Specialist Day"

This legislation is being introduced at the request of the Wisconsin Association of Benefits Specialists. Please indicate this in the co-sponsorship line.

Each year, the Wisconsin Association of Benefits Specialists requests that the Governor declare a certain day to be "Benefit Specialist Day." This legislation would establish a permanent standing date, the second Thursday of July, to be "Benefit Specialist Day." The purpose of this day is to recognize the contributions that elderly benefits specialists make to the well-being of seniors throughout our state. This day would bring attention to the special work that these professionals do in our communities every day for many of society's most vulnerable members. Specifically, benefit specialists provide information, assistance and representation regarding a wide variety of benefit issues and elder rights topics, and help older residents cut through bureaucratic red tape. Finally, establishing a standing date for the day would draw attention to services available to elderly citizens, and result in more seniors accessing these services through the office of their local benefits specialist.



A PROCLAMATION

WHEREAS, the people of the State of Wisconsin respect and value our older residents and their accomplishments; and

WHEREAS, the Wisconsin Association of Benefit Specialists acknowledges the need for the services provided through Wisconsin's Benefit Specialist Programs; and

WHEREAS, the Wisconsin Association of Benefit Specialists have experience and knowledge of the needs of older residents; and

WHEREAS, one primary responsibility of all Aging Network units in Wisconsin, and specifically the Benefit Specialist Program, is to provide information to the public about benefits, services, options and legal rights for older Wisconsin residents;

NOW, THEREFORE, I, TOMMY G. THOMPSON, Governor of the State of Wisconsin do hereby proclaim July 8, 1998

BENEFIT SPECIALIST DAY

in the State it wiscons, and commend this observance to the citizens of this state.

AN ACT ...; relating to: designation of a date as "Benefit Specialist Day".

Analysis by the Legislative Reference Bureau

This bill designates the second Thursday in July as "Benefit Specialist Day" and requires that the governor issue annually a suitable proclamation for the observance of the day.

For further information *see* the *state* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 14.16 (10) of the statutes is created to read:

14.16 (10) BENEFIT SPECIALIST DAY. To recognize the contribution that elderly

benefit specialists make throughout this state to the well-being of senior citizens,

many of whom are society's most vulnerable members, the second Thursday in July

- is designated "Benefit Specialist Day". The governor shall issue annually a suitable
