1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 2: after "facilities" insert "*and*", reducing the use of out-of-state
3 correctional facilities"

4 **2.** Page 2, line 6: after that line insert:

5 "SECTION **2m.** 301.221 of the statutes is created to read:

6 **301.221 Prisoners at leased correctional facilities.** The department *& you* & *may*
7 not confine a prisoner in a correctional facility *that* it leases under s. 13.48 (27) unless the
8 department is returning the prisoner to this state from a correctional facility *located* outside
9 of this state."
