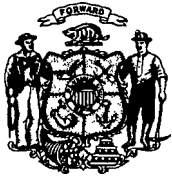

At the request of the State Bar, we would like to have drafted a simple amendment to AB 562 (Southeast Wisconsin crime abatement task force) adding language to add to the task force a member of the State Bar of Wisconsin's Criminal Law Section who lives in the affected area, as well as a member of a local bar association for every county enumerated as part of the task force in the bill (i.e., Milwaukee, Kenosha, Racine, Rock and Waukesha).
