



AN ACT to repeal and recreate 15.405 (6) (a) and 15.405 (6) (b) of the statutes;

relating to: membership of the dentistry examining board.

Analysis by the Legislative Reference Bureau

Under current law, the dentistry examining board (board) includes six dentist and three dental hygienist members and, on December 31, 2002, the number of dentist members is reduced to five and the number of dental hygienist members is reduced to one. This bill eliminates the reduction of members so that, on December 31, 2002, the board includes six dentist and three dental hygienist members.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- **SECTION 1.** 15.405 (6) (a) of the statutes, as affected by 1997 Wisconsin Act 96, is repealed and recreated to read:
- 5 15.405 (6) (a) Six dentists who are licensed under ch. 447.
 - **SECTION** 2. 15.405 (6) (b) of the statutes, as affected by 1997 Wisconsin Act 96, is repealed and recreated to read:
