Re: AB 620

Adrienne,

I would like the following Amendments drafted to **AB 620**:

- 1) Reiating to the increase in Small Claims Court jurisdiction from **\$5,000.00** to **\$6,000.00**. I believe this would be in Sections 2-4 of the Rill.
- 2) Section 16. **Regarding** the award of attorney's fees, for amounts **\$6,000.00** or over, the attorney's fees to be awarded may not exceed **\$750.00**. When the amount awarded is **from \$3,000.00** up to **\$6,000.00**, the attorney's fees awarded may not exceed **\$500.00**. For amounts under **\$3,000.00**, the attorney's fees awarded may not exceed **\$250.00**. In all other cases in which there is no amount recovered or that do not involve property, attorney's fees may not exceed **\$500.00**.
- 3) Regarding Section 32, delete the change made proposed in AB 620 and retain current law requiring an Affidavit of Service or Mailing to be provided.
- 4) Regarding Section 33, delete the new provisions of A13 620 and retain current law.
- 5) 'Delete the new authority being created in Section 1.

All of these Amendments should be drafted as separate Amendments to this Bill.
