Re: AB 620

Adrienne,

I would like the following Amendments drafted to **AB 620**:

- 1) Relating to the increase in Small Claims Court jurisdiction from **\$5,000.00** to **\$6,000.00**. I believe this would be in Sections 2-4 of the Bill.
- 2) Section 16. Regarding the award of attorney's fees, for amounts \$6000.00 or over, the attorney's fees to be awarded may not exceed \$750.00. When ~~the~~ amount awarded is ~~from~~ **\$3,000.00** up to **\$6,000.00**, the attorney's fees awarded may not exceed \$500.00. For amounts under **\$3,000.00**, the attorney's fees awarded may not exceed \$250.00. In all other cases in which there is no amount recovered or that do not involve property, attorney's fees may not exceed \$500.00.
- 3) Regarding Section 32, delete the change made proposed in **AB 620** **and** retain current law requiring an Affidavit of Service or Mailing to be provided.
- 4) Regarding Section 33, delete the new provisions of AB 620 and retain current law.
- 5) Delete the new authority being created in Section 1.

All of these Amendments should be drafted as separate Amendments to this Bill.
