ASSEMBLY AMENDMENT, TO 1999 ASSEMBLY BILL 620

At the locations indicated, amend the bill as follows:

1. Page 8, line 5: delete lines 5 to 13 and substitute:

"814.04 (1) (a) When the amount recovered or the value of the property involved is \$1,000 or over greater than \$7,500, attorney fees shall be \$100 not exceed \$500; when it is eaual to or less than \$1,000 and is \$500 or over, \$50 \$7,500 but is \$4,000 or more, attorney fees shall not exceed \$350; when it is less than \$500 and is \$200 or over, \$25; and when it is less than \$1.000 or more, attorney fees shall not exceed \$250; and when it is less than \$1.000, attorney fees shall not exceed \$100. In all other cases in which there is no amount recovered or that do not involve property, attorney fees shall not exceed \$500.".
