1 At the locations indicated, amend the bill as follows:

- 2 ✓ 1. Page 2, line 12: delete the material beginning with “Under” and ending with
- 3 the period on line 16 and substitute “Under the system, the department may not
- 4 register a reduction in emissions of greenhouse gases if the reduction was made
- 5 before January 1, 1991.”.
