4 48.365 (2g) (b) 2m. A description of any efforts to place the child for adoption,  
5 with a guardian or in some other alternative permanent placement that were made  
6 under s. 48.355 (2b) at the same time as the efforts required under s. 48.355 (2) (b)  
7 6. to make it possible for the child to return safely to his or her home were made."

8 2. Page 15, line 23: delete lines 23 to 25.

9 3. Page 16, line 1: delete lines 1 and 2 and substitute:

10 **SECTION 37g. 938.365** (2g) (b) 2m. of the statutes is created to read:

11 938.365 (2g) (b) 2m. A description of any efforts to place the juvenile for  
12 adoption, with a guardian or in some other alternative permanent placement that
