- 1 **At** the locations indicated, amend the bill as follows:
- 2 1. **Page 1**, line 2: delete ~~the material beginning with "transaction" and ending~~ ^{"transaction fees for issuing fishing"} ~~with "transaction" and ending~~ ✓

- 5 2. **Page 2**, line 1: before that line insert:
- 6 "SECTION 1b. 29.556 (2) (d) of the statutes is created to read:
- 7 29.556 (2) (d) **If** the department or an agent appointed under s. 29.024 (6) (a)
- 8 2. [✓] or 3. collects a handling fee for in-person credit transaction costs, the department
- 9 or agent may not collect the handling fee from a person who is paying with a credit
- 10 card for transaction fees imposed under s. 29.56 if the total of those transaction fees
- 11 exceeds the handling fee for in-person credit transactions costs ^{that would} ~~that is being~~ ✓
