**ASSEMBLY AMENDMENT,
TO 1999 ASSEMBLY BILL 664**

1 At the locations indicated, amend the bill as follows:

2 ✓ 1. Page 1, line 4: delete "handgun" and substitute "handgun, authorizing the
3 department of justice to prosecute violations of certain laws regulating firearms".

4 **2.** Page 4, line 20: after that line insert:

5 "SECTION 5d. 175.35 (4) of the statutes is created to read:

6 175.35 (4) The department of justice or the district attorney may institute,
7 manage, control and direct, in the proper county, a prosecution for violation of this
8 section. When prosecuting violations of this section, the department of justice shall
9 have and exercise all powers conferred upon district attorneys.

10 **SECTION 5t.** 941.29 (11) of the statutes is created to read:

11 941.29 (11) The department of justice or the district attorney may institute,
12 manage, control and direct, in the proper county, a prosecution for violation of this

1 section. When prosecuting violations of this section, the department of justice shall
2 have and exercise all powers conferred upon district attorneys.“
