2 1. Page 63, line 22: after that line insert:

3 "(5) CONSULTATION WITH LICENSE HOLDERS. The department shall send written

a4 notification of any rule that is <sup>proed</sup> ~~proposing~~ under this chapter to each person holding

5 a license under this chapter for the person's review or comment. The department

6 shall send the notification at least 60 days before the notice stating that the proposed

7 rule is in final draft form is submitted to the legislature in the manner provided

8 under s. 227.19 (2). Upon request of any license holder, the department shall send

9 to the license holder a copy of the proposed rule within 7 days after the receipt of the

10 request. A license holder may submit written comments on <sup>g</sup> ~~the~~ the proposed rule to

1 the department. The department shall include any written comments that it  
2 receives in the report required under s. 227.19 (3).”
