### ASSEMBLY AMENDMENT, TO 1999 ASSEMBLY BILL 701

At the locations indicated, amend the bill as follows:

1. Page 25, line 3: delete the material beginning with that line and ending with page 26, line 2 and substitute:

**"SECTION** 27m. 8.35 (4) (c) and (d) of the statutes are amended to read:

8.35 (4) (c) The transfer to the replacement candidate under par. (b) shall be made and reported to the appropriate filing officer in a special report submitted by the former candidate's campaign treasurer. If the former candidate is deceased and was serving as his or her own campaign treasurer, the former candidate's petitioner or personal representative shall file the report and make the transfer required by par. (b), if any and file the renort. The report shall be made, in the manner provided under s. 11.21 (16), if applicable, or otherwise at the appropriate interval under s. 11.20 (2) or (4) and shall include a complete statement of all contributions,

disbursements and incurred obligations pursuant to s. 11.06 (1) covering the period
from the day after the last date covered on the former candidate's most recent report
to the date of disposition.

- (d) The newly appointed candidate shall file his or her report in the manner provided under s. 11.21 (16). if annlicable, or otherwise at the next appropriate interval under s. 11.20 (2) or (4) after his or her appointment. The appointed candidate shall include any transferred funds moneys in his or her first report.".
