

Analysis by the Legislative Reference Bureau

Current law imposes a recycling fee of 30 cents per ton for solid **ar hazardous** waste, other than certain kinds of high-volume industrial waste, disposed of at a landfill or other waste disposal facility. This type of fee is often called a tipping fee. The recycling fee is deposited in the recycling fund.

This bill increases the recycling fee to \$2.00 per ton.

For further information *see* the *state and local* fiscal estimate, which will be printed as an appendix to this bill.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

SECTION 1. 289.645 (3) (intro.) and (a) of the statutes, as created by 1999 Wisconsin Act 9, are consolidated, renumbered 239.645 (3) and amended to read:


