- 3 1. Page 3, line 12: ~~before the period~~ insert ", except that "athletic agent" does
- 4 not include a relative of the student athlete".
- 5 2. Page 4, line 23: after that line insert:
- 6 "(jm) "Relative" means any of the following:
- 7 1. A parent, grandparent, stepparent, brother, sister, uncle or aunt, regardless
- 8 of whether the relationship is by blood, marriage or adoption.
- 9 2. A guardian or legal custodian." ✓
- 10 3. Page 5, line 6: after "(3)" insert " or the individual is a relative of the student
- 11 athlete". ✓
