TO ASSEMBLY AMENDMENT 1,
TO 1999 ASSEMBLY BILL 721**

1 At the locations indicated, amend the amendment as follows:

2 ✓ **1.** Page 2, line 14: after "occurs." insert "In formulating its recommendation
3 under this paragraph, the Wisconsin District Attorneys' Association shall consider
4 the trends of population increase or decrease within the prosecutorial unit in which
5 the vacancy has occurred."

6 ✓ **2.** Page 2, line 22: delete lines 22 to 24 and substitute "vacancy occurs. In
7 making its decision under this paragraph, the department of administration shall
8 consider both the trends of population increase or decrease within the prosecutorial
9 unit in which the vacancy has occurred and the recommendation prepared by the
10 Wisconsin District Attorneys' Association under par. (b). If the department of
11 administration decides under".
