

Assumptions Used in Arriving at Fiscal Estimate The bill permits the Legislative Audit Bureau to audit the proposed district and requires that the Legislative Audit Bureau report biennially on the financial status of the district. The audit and reporting activities can be accommodated within current agency operations.		
Long-Range Fiscal Implications To the extent the Audit Bureau were to perform additional audit work relating to the proposed district, other audit assignments may be delayed to accommodate the district audit.
