1 At the locations indicated, amend the bill, as shown by senate substitute
2 amendment 2, as follows:

3 **1.** Page 14, line 2: after "tribe" insert "before that assessment or those services
4 are offered. The explanation shall include notice that a provider of home visitation
5 program services under this section ^{who} is required under s 48.981 (2) to report any
6 suspected or threatened abuse or neglect of a child seen in the course of providing
7 those services ^{shall report it} and that, if a report is made, the agency, as defined in s. 48.981 (1) (ag),
8 receiving the report will initiate an investigation of the report within 24 hours after
9 receipt of the report."

1. Page 3, line 8: after that line insert:

“SECTION 4p. 46.515 (6g) (b) of the statutes is amended to read:

46.515 (6g) (b) A county or Indian tribe that is selected to participate in the program under this section shall provide or shall designate an individual or entity to provide an explanation of the confidentiality requirements under par. (a) to each individual who is offered an assessment under sub. (4) (b) or who is offered services under the home visitation program of the county or Indian tribe before that assessment or those services are offered. The explanation shall include notice that a nrovider of home visitation program services under this section who is reauired under S. 48.981 (2) to renort any susnected or threatened abuse or neglect of a child seen in the course of the nrovider’s nrofessional duties must renort anv susnected or
