1 . Page 3, line 9: after that line insert:

3 "SECTION 4k. 46.515 (6) (a) 8. of the statutes is created to read:

4 46.515 (6) (a) 8. A statement that the applicant will not attempt to visit a home
5 without first notifying the parent, guardian or legal custodian of the child not less
6 than 48 hours prior to the time of the visitation."
