1 **AN ACT** to create 78.018 of the statutes; **relating to:** reducing the gas tax rate.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

2 SECTION 1. 78.018 of the statutes is created to read:

3 **78.018 Adjustment in the year 2000.** On July 1, 2000, the rate of the tax  
4 imposed under s. 78.01 (1) is decreased by 3 cents.
