

#### Analysis by the Legislative Reference Bureau

Current law requires that **aidable** costs incurred for special education by school districts, cooperative educational service agencies, county children with disabilities education boards and certain charter schools be fully reimbursed by the state, subject to the availability of funds.

This bill provides for most aidable costs for special education to be reimbursed by the state at the rate of 63%. The salaries of school psychologists and social workers are reimbursed at 51% and the costs of special education for children in hospital and convalescent homes are fully reimbursed. The bill provides that if insufficient funds are appropriated, payments are prorated.

For further information *see* the *state and local* fiscal estimate, which will be printed as an appendix to this bill.
