2 1. Page 2, line 7: delete lines 7 to 12 and substitute: ✓

3 "27.01 (7m) (bm) 1. In this paragraph, "friends group" has the meaning given

4 in section 23.098 (1) (b). ✓

5 2. An agent appointed under par. (a) that is a friends group may retain an
6 amount equal to 10% of the sum of the following amounts to compensate the friends
7 group for the friends group's services in issuing vehicle admission receipts. ✓

8 2. Page 2, line 13: delete "1." and substitute "a."

9 3. Page 2, line 15: delete "2." and substitute "b."
