1 within this state unless the snowmobile is registered for public use or private use

13 until ownership of the snowmobile is transferred. The fee for the issuance or renewal
14 of a public-use registration certificate is ~~\$20 \$50 \$40~~ except that the fee is \$5 if it is a
15 snowmobile owned and operated by a political subdivision of this state. There is no
16 fee for the issuance of a private-use registration certificate or for the issuance of a
17 registration certificate to the state.

18 SECTION 23. Appropriation changes.

19 (1) SNOWMOBILE LAW ENFORCEMENT AND SAFETY. In the schedule under section
20 20.005 (3) of the statutes for the appropriation to the department of natural
21 resources under section 20.370 (3) (aq) of the statutes, as affected by the acts of 1999,
