**ASSEMBLY AMENDMENT,**  
ASA - (CRB 50469)  
**TO 1999 ASSEMBLY BILL 916**

Now

1 At the locations indicated, amend the bill as follows:

2 1. Page 1, line 3: after "program" insert "and to supplement a medical  
3 assistance program appropriation for a medical assistance outreach program".

4 2. Page 2, line ~~7~~<sup>1</sup> delete lines ~~7~~<sup>1</sup> to ~~9~~<sup>3</sup> and substitute:

5 "20.865 (4) (d) *Badger care health care program and medical assistance*  
6 *outreach supplement*. A sum sufficient to supplement the appropriation under s.  
7 20.435 (4) (bc) as provided in 1999 Wisconsin Act . . . . (this act), section 4 (1) and to  
8 supplement the appropriation under s. 20.435 (4) (bm) as provided in 1999 Wisconsin  
9 Act . . . . (this act), section 4 (2).".

10 3. Page ~~30~~<sup>2</sup> line ~~17~~<sup>18</sup> delete the material beginning with "sections" and ending  
11 with "statutes, from" on line ~~17~~<sup>19</sup> and substitute "section 13.101 (3) and (4) of the  
12 statutes, from".

13 4. Page 3, line ~~17~~<sup>2</sup> after that line insert:

1 " (2) MEDICAL ASSISTANCE OUTREACHPROGFUMSUPPLEMENT.

3 (a) The joint committee on finance may transfer in the 1999-2001 fiscal  
4 biennium appropriated moneys from the general purpose revenue appropriation  
5 account of any state agency, as defined in section 20.001 (1) of the statutes, other than  
6 a sum sufficient appropriation account, to the appropriation account under section  
7 20.435 (4) (bm) of the statutes for a medical assistance outreach program if the  
8 committee finds that the transfer will eliminate unnecessary duplication of  
9 functions, result in more efficient and effective methods for performing programs or  
10 more effectively carry out legislative intent, and that legislative intent will not be  
11 changed by the transfer.

12 (b) Notwithstanding paragraph (a) and section 13.101 (3) and (4) of the  
13 statutes, from the appropriation under section 20.865 (4) (d) of the statutes, the joint  
14 committee on finance may supplement in the 1999-2001 fiscal biennium the  
15 appropriation to the department of health and family services under section 20.435  
16 (4) (bm) of the statutes, for a medical assistance outreach program."
