1 **AN ACT to amend** 20.435 (4) (bc) of the statutes; **relating to:** authorizing the
2 joint committee on finance to supplement an appropriation for the badger care
3 health care program and to supplement an appropriation for a medical
4 assistance outreach program and making appropriations.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

5 **SECTION 1.** 20.435 (4) (bc) of the statutes, as affected by 1999 Wisconsin Act 9,
6 is amended to read:
7 20.435 (4) (bc) *Health care for low-income families.* ~~As a continuing~~
8 ~~appropriation~~ *Biennially,* the amounts in the schedule for the badger care health care
9 program for low-income families under s. 49.665.
