SECTION 1. 20.435 (4) (bc) of the statutes, as affected by 1999 Wisconsin Act 9, is amended to read:

20.435 (4) (bc) Health care for low-income families. As a continuing appropriation Bienmally, the amounts in the schedule for the badger care health care program for low-income families-under s. 49.665.

"Section 2. Nonstatutory provisions.

(1) Badger care health care supplement. From the appropriation account under section 20.865 (4) (a) of the statutes, the joint committee on finance may
