2. Page 5, line 22: after that line insert:

"Section 10e. 77.52 (2) (a) 6. of the statutes is amended to read:

77.52 (2) (a) 6. Laundry, dry cleaning, pressing and dyeing services, except when performed on raw materials or goods in process destined for sale, except when performed on cloth diapers by a diaper service, except when performed on reusable incontinent undernads and briefs, regardless of their size, and except when the service is performed by the customer through the use of coin-operated, self-service machines.

SECTION 10g. 77.54 (40) of the statutes is amended to read:

1 77.54 (40) The gross receipts from the sale, lease or rental of and the storage,
2 use or other consumption of cloth diapers and of reusable incontinent undernads and
3 briefs. regardless of their size.".
