SENATE AMENDMENT,
TO 1999 ASSEMBLY JOINT RESOLUTION 12

1 At the locations indicated, amend the joint resolution as follows:

2 ✓1. Page 1, line 8: delete "on October 7, 1998" and substitute "during the 105th
3 Congress".

4 ✓2. Page 1, line 10: delete "1998)" and substitute "1998) that would provide
5 additional revenue to Wisconsin for conservation purposes".

6 ✓3. Page 1, line 13: delete the material beginning with that line and ending with
7 on page 2, line 10 and substitute:
